

## **PRIVACY POLICY**

DXDMed Inc. (hereinafter collectively referred to as "we"/"us"/"our ") recognizes that the protection of personal information is an important social responsibility and has established the following personal information protection guidelines for handling, controlling and maintaining personal information.

This Privacy Policy describes the measures we take to protect the security of your personal information. The use of this website is covered by this Privacy Policy.

Personal Information Protection Guidelines are as follows:

1. Collection, use, and provision of personal information

When collecting, using and providing personal information, we recognize the importance of protecting personal information and deal with all such information in an appropriate manner.

2. Implementation of safety measures

We maintain an optimum system for stringently controlling personal information, and by building logical safety control measures, we have developed thorough preventative and corrective policies against the illegal access to personal information, as well as the loss, destruction, falsification and leakage of personal information.

3. Implementation of continuous improvement

We have established a compliance program for the protection of personal information, and while implementing and maintaining the program, we make regular reviews of the program as part of our efforts for continuous improvement.

4. Compliance with laws and regulations

When handling personal information, we shall comply with the obligations set forth in the Act on the Protection of Personal Information, as to various other laws and regulations relating to the protection of personal information, guidelines published by the Personal Information Protection Commission and the competent authorities, as well as to this Policy.

## Handling of Personal Information

We will strive for thorough compliance by properly handling information according to the provisions stipulated by laws, regulations, etc. related to the protection of personal information.

### 1. Basic principles for the protection of personal information

Personal information will be applied by us in the following (all or partly):

- To provide customers with information or services that have been registered or applied to receive.
- To deliver products for which customers have ordered or applied.
- To provide information on related events, exhibitions and seminars.
- To provide information on the results for which customers have cooperated or participated in the events and surveys.
- To provide services by direct mail, e-mail, and fax.
- To inform on the results of Recruitments.
- To conduct other services that are related to the above.

### 2. Regarding provision of personal information

Personal information shall never be disclosed or entrusted to a third party, except when the information subject has given consent for such disclosure or entrustment.

### 3. Regarding Shared use of personal information

Our company and our appropriately selected affiliated companies will share the use of personal information to accomplish the objective stated in 1. All personal information will be appropriately managed.

### 4. Treatment of personal information by external links / parties

This website may contain links to external websites. We are not responsible for the treatment of information for external sites. Please contact the external sites to find out about their privacy policy.

### 5. Transfer of personal information

In order to conduct certain services, it is necessary to transfer certain information to contracted third parties. In this event, we supervise the treatment of personal information by these third parties to ensure the protection of your information. The information passed down to third parties by us is protected under contract which we supervise.

### 6. Changes to registered information

At DXDMed Inc, we file our customer information according to the specific service that you have requested. If at any time, a customer requests to delete or change the registered information, after proper identification, unless there are unusual circumstances, we will oblige to the request.
